Article 1:

Name. The name which this parish is to be identified is "Bulgarian Eastern Orthodox Church "Saint Nicholas", Inc.

Article 2:

Place of business. The initial street address of the principal place of business of the parish shall be:

Article 3:

Purpose. The purpose of this Declaration is to establish a place of worship and to unite spiritually and ecclesiastically in the name of Lord Jesus Christ, the religious Eastern Orthodox Christians, living in Broward, Dade, Palm Beach Counties and their vicinities; to satisfy their religious and spiritual needs and to meet their Church requirements.

The parish shall be organized and operated exclusively for charitable, religious, educational and scientific, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the United States Internal Revenue Code, or corresponding section of any future United States federal tax code.

It is a non-profit Organization and is alien to any speculative purposes.

The purposes and activities of the parish may not be illegal or violate fundamental public policy.

No substantial part of the activities of the parish shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the parish shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article 4:

b) To have and support its own parish priest and if necessary and possible, other church servants.

Article 12:

Membership fee. The parish shall realize its financial support from regular membership duties, voluntary donations, contributions and bequests. The membership dues shall be determined at the Annual General Membership Meeting.

Article 13:

Obligations of Members. All members of the Church shall conform to and abide by the By-Laws and uniform rules and regulations in regard to the membership and the use of the Church's facilities which may be adopted in writing from time to time by the Board of Directors of the Church, and to see that all persons using Church's property do likewise.

All Eastern Orthodox Christians, residing in Broward, Dade, Palm Beach Counties and their vicinities, baptized and/or anointed in the Eastern Orthodox Faith shall be parishioners of the Bulgarian Eastern Orthodox Church "Saint Nicholas".

In order to have the right to participate in governing the parish and in order to qualify to vote and be eligible to be elected to office, the parishioners must declare in writing their desire to be accepted as regular members of the parish "Saint Nicholas", assuming the

obligations to be faithful Orthodox Christians, to meet regularly the religious and church requirements and the local financial obligations.

Article 14:

The newly accepted members. The newly accepted members shall have the right to attend the general membership meetings, to take the floor, to discuss issues, and make motions, but they shall have the right to vote after they have been members of good standing for one year and in order to have the right to be eligible for office, they must have been members of the parish in good standing for a period of at least two years.

Article 15:

The duties of the Board of Directors. The members of the Board of Directors shall:

1. Attend the Divine Services regularly, in order to set an example of fulfillment of Christian duty.

2. Meet each month, and if necessary, the President shall call Special meetings.

3. Control the real estate, the inventory, and the other property of the parish.

4. Control, examine and determine the proper entries of all income and expenditures of the parish entered by the Treasurer in his records.

5. Give financial and inventory reports to the annual General Membership Meetings.

6. Receive all the income and to determine and control the expenditures of the parish.

7. Determine the salary of the parish priest and the salaries of other church servants if there are any.

8. See that the parish has title for all its property.

9. Have the custody of the title documents of all the properties of the parish.

Article 16:

<u>Authority</u> The Board of Directors shall have the authority to hire or fire the parish priest only if a simple majority (+50%) of the members at the Special Membership Meeting, called for that purpose, shall decide so; providing that a quorum is established.

The Board of Directors shall have the authority to spend an amount greater than \$4,999.99 only if a simple majority (+50%) of the members at the Special Membership Meeting, called for that purpose, shall decide so; providing that a quorum is established.

The Board of Directors shall have the authority to buy property for the parish or sell parish property only if a simple majority (+50%) of all Voting Members at the Special Membership Meeting, called for that purpose, shall decide to buy or sell the parish property.

The Board of Directors shall have the authority to take credit or loans only if seventy five percent (75 %) or more of all voting members at the Special Membership Meeting, called for that purpose, shall decide to take a credit or a loan.

Article 17:

Parish priest. The parish priest is the Servant of the Lord Jesus Christ and Spiritual Leader of the parish. His duties shall be to fallow the Holy ecclesiastic laws and Bylaws of the parish "Saint Nicholas", to celebrate Divine Liturgy every Sunday and every Church holy

day during the week, to direct the Sunday School, to give moral support to anyone seeking his help, and to assist the Board of Directors in all his parish activities. The parish priest should not attend any political meetings. Should he leave the parish, he must seek the blessing of his Metropolitan and notify the Board of Directors. The parish priest must keep regular records of all baptismal, weddings, and funerals. The Board of Directors may permit the priest to hold free baptismal, and funeral services for poor Eastern Orthodox Christians not able to afford the regular fee.

When the Church is left without a priest, the Board of Directors shall petition the Diocesan Prelate, in writing with a request for a priest. A Special Membership Meeting of the parish, duly called for such a purpose, shall approve the new priest with a majority vote. The parish priest must also be approved by the Diocesan Prelate.

Article 18:

Dissolution. The Church may be terminated in the following manner:

One hundred percent (100%) of the Voting members vote to terminate the Church.

Upon the dissolution of the parish, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 19:

Finances, Earnings, Liabilities, Liens, Interest Collection.

Members and Voting members shall have no financial or other liabilities concerning the Church.

No part of the net earnings of the parish shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the parish shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for in Article 1 hereof.

Article 20:

Amendment of Declaration. This Declaration of the Bulgarian Orthodox Church "Saint Nicholas" may be amended by affirmative vote, of three-fourths (¾) of the voting members of the Church at a meeting duly called for such a purpose. A copy of such amendment shall be certified by the President or Secretary of the Church as having been duly adopted and shall be effective when recorded in the Public Records of Dade, Broward or Palm Beach County, Florida.

Article 21:

Invalidation and Operation. Invalidation of any portion of this Declaration or of any portion contained in a conveyance of the Church, whether by judgment, court order, or statute, shall in nowise affect any of the other provisions which shall remain in full force and effect.

Article 22:

Interpretation. Whenever the context so requires, the use of any gender shall be deemed to include all genders, and the use of the plural shall include the singular and the singular shall include the plural. The provisions of this Declaration shall be literally construed to effectuate its purposes of creating a uniform plan for the operation of the Church in accordance with the laws made and provided for Non-for-profit organizations.
