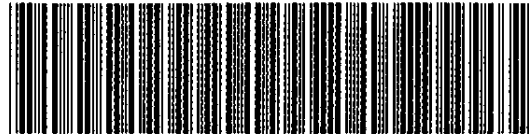

Article VIII DISSOLUTION OF ASSETS

SECRETARY OF STATE
