



ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

FREEDOM ATHLETIC PARENT BOOSTER CLUB, INC. (A corporation Not-for-Profit)

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST:

Amendment adopted: ARTICLE III

Purpose:

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The specific purpose for which this corporation is organized is: To provide an organization to facilitate the development of amateur athletic sports, specifically competitive cheerleading and dance by offering a fun, positive, and competitive athletic experience and develop cheerleading and dance skills in today's young athletes, while contributing to their social, mental, and physical health and well-being by teaching them the value of teamwork, responsibility, self-discipline, leadership, and community service.

Amendment adopted: ARTICLE IV

The manner in which directors are elected or appointed is:

The corporation shall have initially a Board of Directors consisting of four directors. The number of directors may be changed from time to time by the by-laws, provided the number of directors is not reduced below two (2) directors. The by-laws shall set forth the method of election of Directors.

Amendment adopted: ARTICLE V

The name of Florida street address of the registered agent is: Rosemary Browning 290 Gus Hipp Boulevard Rockledge, FL 32955

Amendment adopted: ARTICLE VII

Duration/Dissolution

The duration of the corporate existence shall be perpetual until dissolution. Upon the dissolution of the organization, assets of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Amendment adopted: ARTICLE VIII

Membership

This corporation shall have members. The eligibility, rights, and obligations of the members will be determined by the organization's by-laws.

Amendment adopted: ARTICLE IX

Exemption Requirements

At all times the following shall operate as conditions restricting the operations and activities of the corporation: No part of the net earnings of Freedom Athletic Parent Booster Club shall inure to the benefit or, or be distributable to its members, trustees, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the Freedom Athletic Parent Booster Club shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, Freedom Athletic Parent Booster Club shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Amendment adopted: ARTICLE X

By-Laws

The by-laws of this corporation shall be approved by a majority vote of the Board of Directors. The by-Laws may be amended or rescinded in the same manner.

Amendment adopted: ARTICLE XI

Amendment to Articles

The Articles of Incorporation may be amended by a majority vote of the Board of Directors.
