ARTICLE II

Purpose of the Foundation

The purpose of this foundation is to provide (1) educational services for youth, women and minorities (2) promote education through, but not limited to, workshops, seminars in underserved areas (3) aviation awareness programs to include but not limited to, Aviation Career Education (ACE) camps, (4) programs to promote science and technology, engineering and math, (5) help promote and support other organization to include, but not limited to, other not-for-profit organizations (6) Scholarships.

The foundation is formed exclusively for charitable religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLES IV

Dissolution Clause

Upon the dissolution of the foundation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the foundation is then located, exclusively for such purposes or to such foundation or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
