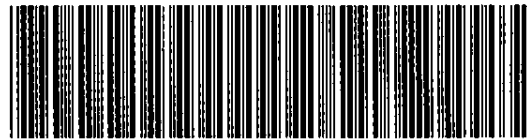

**ARTICLES OF INCORPORATION
OF
"New Wine Gospel Ministry.TV Inc.**

The undersigned incorporators being of full age, for the purpose of establishing a church, a non-profit corporation in compliance with chapter 617, F.S; adopts the following articles of incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be: **New Wine Gospel Ministry.tv Inc.**
The effective date shall be September 6th, 2011.

**ARTICLE II
PRINCIPLE OFFICE**

The principle place of business and mailing address of this corporation shall be: **1648 Amaryllis Circle, Orlando FL 32825.**

**ARTICLE III
PURPOSE**

The purposes for which the corporation is organized are to engage in, assist and contribute to exclusively religious, charitable, educational activities and projects. In order to support such objectives, the primary activity of the corporation shall include but are not limited to:

- a. Be the voice of God on earth; uncompromisingly preach, and propagate the Word of God, present salvation to humanity as well as edify the body of Christ. (Matthew 28:19-20, Mark 16:15, Luke 4:8-18, II Corinthians 7:14; Ephesians 4:15; Colossians 1:5-6; I Timothy 2:7; II Timothy 2:1-2, 4:2)
- b. Propagate the good news of the gospel through religious, educational, and charitable activities as the corporation seems fit, necessary and/or appropriate from time to time.

- c. Rebuild the broken walls of the family and the broken walls of the church using God's word as the foundation, confront spiritual dysfunction and provoke the church to embrace a new paradigm of truth and spiritual maturity.
- d. Resuscitate the spirit of prayer, strategic evangelism, discipleship and stir spiritual hunger, raise a high standard of truth, character, righteousness, and morality in the body of Christ in order to spark the fire of global revival and reformation.
- e. Establish auxiliary clubs and religious societies to promote Christian fellowship in the body of Christ; (II Timothy 2:2, 15) Send forth home and foreign missionaries to spread the gospel throughout the world; establish Christian centers, Christian academic institutions, nationally and internationally to standards set forth by the Bible (Proverbs 8:10, Matthew 28:19-20, Mark 16:15-16, Luke 24:47, II Timothy 2:2, 15)
- f. Plant and establish churches, ministerial organization for the purpose of relationship, networking, mentorship, impartation, and to be a harbor to other churches and ministries.
- g. Ordain and/or license ministers of the gospel so they may engage in religious worship and perform other sacerdotal functions.
- h. Establish Christian music recording studios, film production studios for the purpose of promoting and disseminating the gospel of Jesus Christ through music and films. (Matthew 10:27, Psalms 150:3-6)
- i. Print, publish, distribute and sell books, magazines, and other literature, make and distribute Christian films, record, reproduce, and distribute tapes, use any and all media, including but not limited to radio and television in connection with the purpose of the corporation.(I Chronicles 16:23-24)
- j. Rescue, revive, reform, restore and carry on charitable work for the poor and lost (Leviticus 25:35; Matthew 25:34- 40; Galatians 6:10; Such as feed the hungry soup kitchen, food pantry, clothing closet, prison ministry, (Psalms 142:7, 146:7, Luke 4:18) After – Care Center for released prisoners (Psalms 69:3, Isaiah 49:9-10) Sick and shut in ministry, un- wed mother's home (Luke 4:18) abused wives and children's home, (Deuteronomy 10:18, Acts 6:1, 1 Timothy 5:3-12, 16) housing for the homeless and runaways (Leviticus 25:35, Luke 3:11, II Corinthians 8:14-15) housing for those with addictive behavior (Luke 4:18) Drug and alcohol program (Isaiah 5:11, Habakkuk 2:15, Joel 2:32, Matthew 9:12, Psalms 121:2) Elderly- duties to the elderly (Psalms 92:14, 1 Timothy 5:1, 5:17 Exodus 20:12) Mentally disturbed (Matthew 4:24,

17;15-18) Care for and assist handicapped individuals (Leviticus 19:14, Isaiah 35:5, Mark 7:37, Luke 14:3-14)

- k. Have the right to own, purchase or acquire by gift, bequest, or otherwise, either directly or as a trustee, and to own, hold in trust, use, sell, convey, mortgage, lease, or otherwise dispose; of any real estate or personal property as may be necessary for the furtherance of the gospel. (Ezra 8:28; James 1:17, I Peter 4:10-11, Acts 2:44-45)
- l. Fulfill the above purposes, and all other acts and things that are not documented here; and to exercise all other rights and powers which may be relevant to accomplishing any and/or the ongoing aims and objective of the corporation.

ARTICLE IV STATEMENT OF FAITH

The corporation shall at all times during its existence adhere strictly to a statement of faith as follows:

- a. We accept the entire 66 books of the Bible, as the written word of God. The Bible is an essential and infallible record of God's self-revelation to mankind that leads us to salvation. The Bible is inspired word of God and therefore is free of error in all it teaches. All believers are exhorted to study the scriptures and diligently apply them to their lives. (2Timothy 3:15-17, II Peter 1:21)
- b. We believe that there is one God: Infinite, Eternal, Almighty, and perfect in holiness, truth, and love, eternally existent in three persons: Father, Son, and the Holy Spirit, co-existent, co-equal, co-eternal. (1 John 5:7)
- c. We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in all His miracles, in His atoning death through His shedding of blood to redeem mankind, in His bodily resurrection, in His ascension into the right hand of God and in His second coming to Earth in power and glory. (John 3:16;5:2-23, Hebrews 9:28, Acts 1:9, John 1:14, John21:24-25, 1Corinthians 15:3-4, Hebrews 2:14-17)
- d. We believe that, "All have sinned and come short of the glory of God" (Romans 3:23, Ephesians 2:8, Romans 5:6-11 Acts 4:12) Therefore, All need salvation through Jesus Christ.

- e. We believe in the rapture of the saints "For the Lord himself shall descend from heaven with a shout, with the voice of the archangel, and with the trump of God: and the dead in Christ shall rise first; Then we which are alive and remain shall be caught up together with them in the clouds, to meet the Lord in the air and so shall we ever be with the lord." (1Thessalonians 4:16-17)
- f. We believe in the ministry and the sanctifying power of the Holy Spirit by whose indwelling the Christian is empowered to live a holy life.
- g. We believe in the baptism in the Holy Spirit, Divine healing, the Nine Gifts of the Holy Spirit, five fold ministry, laying on of hands, Deliverance, Tithing and Offerings as commanded of God to be observed by all and used for the propagation of the gospel according to scriptures (1Corinthians 9:7-14, I Corinthians 12, James 5:13-14, Malachi 3:8-12)
- h. We believe in the ordinances of the church such as;
 - i. Water baptism by immersion as prescribed by the scripture and administered in the name of the Father, the Son, and the Holy Spirit (Matthew 28:19, Acts 8:36-38; 19:35)
 - ii. We believe and observe the Lords supper with unfermented wine and unleavened bread according to Matthew 26:26-28)
- i. We believe in the resurrection of both the saved and the lost; they that are saved unto the resurrection of life, and they that are lost unto the resurrection of damnation; (Matthew 25:34, 41, 46, Revelation 21:8) and the millennial reign of Christ.
- j. We believe in the spiritual unity and fellowship of believers in our Lord and savior, Jesus Christ.

ARTICLE V

BOARD OF DIRECTORS/MANNER OF ELECTION

- a. The corporation shall be managed by a board of directors. The number of the board of directors shall be determined by the Bylaws of the corporation and may be altered by amending the Bylaws, but shall never be less than required by law.
- b. The term of office of the board of directors shall be fixed by the Bylaws of the corporation and may be altered by amending the Bylaws. But, the term of

office of the board of directors shall not be less than 1 year. Members of the board of directors shall serve until the end of the term fixed by the Bylaws at which they may either be reelected or removed and/or, successors are elected into the office as provided by the Bylaws.

No member, officer, or director of this corporation shall be personally liable for debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VII DURATION

The duration of this corporation existence shall be perpetual.

ARTICLE VIII AMENDMENT OF ARTICLES

The above articles may be amended as is now or here after as prescribed by law subject to any provisions of the bylaws regarding amendment of the article.




