

# ARTICLES OF INCORPORATION OF

# Actively Visiting Orphans, Widows, Elderly and Disabled, Inc.

A Florida "Not for Profit" Corporation

The undersigned, acting as Incorporators of a Corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

# **ARTICLE I**

#### NAME OF CORPORATION

The name of the Corporation is Actively Visiting Orphans, Widows, Elderly and Disabled, Inc.

# **ARTICLE II**

#### PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office and mailing address of the Corporation is:

# <u>ARTICLE III</u>

#### **PURPOSES**

The purposes for which this Corporation is organized is exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

More particularly, to care for orphans, widows, elderly and the disabled. Emotionally and spiritually accepting them no matter who they are, where they came from, where they are, or faith level, or lack of faith. Telling and showing all that God loves them and we love them.

# Especially sensitive and responsive to the following purposes, but not exclusive:

- Visit and help orphans, widows, elderly and the disabled in distress.
- Minister with compassion to those with end of life issues.
- Help orphans, widows, elderly and the disabled escape persecution or natural disasters.
- Conduct and manage church and worship services for orphans, widows, elderly and the disabled wherever they may be located.
- Create tailored religious, worship and teaching resources to the appropriate demographics in various ways. Examples may include in the form of song books, large print Bibles and devotional material such as in church or worship services; and teaching, training or discipleship material geared to orphans, widows, elderly and the disabled.
- To research and educate people on issues related to orphans, widows, elderly and the disabled.
- To support spiritual formation, discipleship and professional development in support of Interns, young people, volunteers and others as they get plugged into ministry for orphans, widows, elderly and the disabled.
- To be an advocate and stand up for the rights of orphans, widows, elderly and the disabled.

# **ARTICLE IV**

#### **DURATION**

The period of duration is perpetual.

# <u>ARTICLE V</u>

#### MEMBERSHIP

The Corporation will not have members.

# **ARTICLE VI**

#### **ELECTION OF BOARD OF DIRECTORS**

The method of selection of the Board of Directors and the number of Directors shall be stated in the Bylaws. In no event, shall the number of Directors be fewer than three.

# **ARTICLE X**

#### **EXCLUSIVITY AND 501(c)(3) LIMITATIONS**

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article three hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on:

- (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or
- (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

# **ARTICLE XI**

#### DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

# **ARTICLE XII**

#### EFFECTIVE DATE

The effective date for the Corporation is July 12, 2011.
