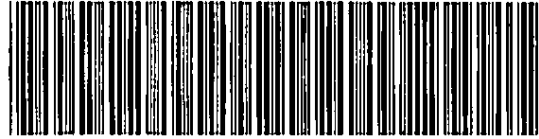

Amend Article III to add the following:

This business is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code.

Add Article IX:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its officers or individuals,

except to further our exempt purpose of providing financial support to the students of the Newsome High School Orchestra,
and except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and
to make payments and distributions in furtherance of the purposes described in section 501(c)3. No substantial part of the
activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the
corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for
public office. The corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt
from federal income tax under section 501(c)3 of the Internal Revenue Code.

Add Article X:

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of
section 501(c)3 of the Internal Revenue Code, or distributed to the federal, state, or local government for a public purpose.
