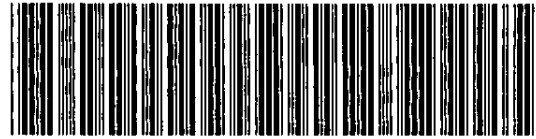

Article VIII
