The undersigned subscribers to these Articles of corporation, desiring to form a corporation under the laws of the State of Florida, do hereby accept all the rights ad privileges, benefits an obligations conferred and imposed by said hereby adopt the following Articles of Incorporation hereby organized pursuant to the Dade and Broward county Nonprofit code.

Article I

Name

Terms of Existence

This corporation shall have perpetual existence as a nonprofit mutual benefit corporation.

Article IV.

Purpose and Powers

- (A) This Corporation is organized for the purpose of engaging in spiritual, charitable, vocational and educational purposes to aid poor and disadvantaged individuals and families toward a life of spiritual and moral uplift and self-sufficiency. - (B) Notwithstanding any other provision of these Articles, The Corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) of the Internal Revenue Code.
- (C) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section © (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose.
