**ARTICLE I
NAME**

The name of the corporation shall be Knock Cancer out of the Park, Inc.

**ARTICLE II

**ARTICLE III
PURPOSE**

Knock Cancer out the Park, Inc., is a not for profit corporation whose purpose is to operate and run annual softball tournaments to raise money for cancer research in an effort to find a cure. Knock Cancer out of the Park intends to donate money raised from its softball tournament to the American Cancer Society initially as well as other not for profit entities whose mission is to find a cure for cancer in all its forms.

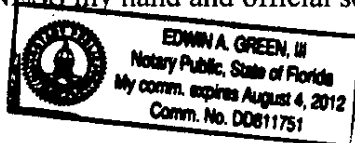


