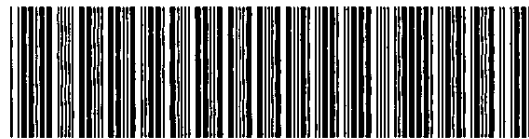

**FIRST:**

**ARTICLE II - PURPOSE AND PREROGATIVES**

The general nature and object of this corporation is for the purpose of establishing and maintaining a place for the worship of Almighty God, our heavenly Father; to provide for Christian fellowship for those of like precious faith, where the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and in foreign lands; we, whose names appear upon the roster of the **JEHOVAH JIREH COMMUNITY CHURCH, ASSEMBLY OF GOD, ST CLOUD, FL, INC.** as of the date of this signing, do hereby recognize ourselves as a local assembly in fellowship with and a part of the General Council of the Assemblies, with headquarters at 1445 Boonville Avenue, Springfield, MO and in fellowship with and a part of the **Florida Multicultural District Council of the Assemblies of God, Inc.** and adopt the following articles of church order and submit ourselves to be governed by them.

**SECOND:**

**ARTICLE XIV - DISSOLUTION**

**Section I**

In the event this corporation shall cease to function for the purposes herein set forth, then all property, real or chattel, shall revert to the **Florida Multicultural District council of the Assemblies of God, Inc.**, under whose supervision this church functions, or to the parent body, the General Council of the Assemblies of God, a Missouri Corporation with headquarters at Springfield, Missouri. The **Florida Multicultural District council of the Assemblies of God and/or the General council** shall have full authority to sell such property and to use the proceeds derived therefrom for the extension of the work of the Spanish Assembly of God specially those churches that this corporation may have established as daughter churches.
