ARTICLES OF INCORPORATION

ARTICLE I: NAME

The name of the corporation shall be Delray Beach Interfaith Clergy Association, Inc.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is to act as an interfaith association of clergy, ministry professionals and faith representatives, united in service for the betterment of the community. Said corporation is organized exclusively for charitable, religious and educational purposes, including the making of distributions to organizations that qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: MANNER OF ELECTION

Officers and directors are elected annually by a majority vote of the members.

ARTICLE V: ACTIONS OF THE CORPORATION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VI: DISSOLUTION OF THE CORPORATION

Upon the dissolution of the corporation, assets shall be distributed to an active interfaith nonprofit corporation whose purpose is for community service in the Delray Beach area. If such an organization is not available, then to the city of Delray Beach for a public purpose.
