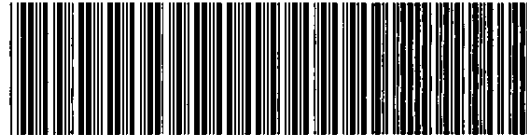

ARTICLES OF INCORPORATION

Article I: NAME

Word of Hope Church of God in Christ Inc.

Article II: PRINCIPAL OFFICE

Article III: PURPOSE

The Word of Hope Church of God in Christ Inc. shall represent the denomination in the spirit of its administration.
