**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

The organization, DUO 58 Inc., is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Notwithstanding any other provision of these articles this corporation shall not, except to insubstantial degree, engage in any activities, or exercise any powers not in furtherance of section 501(c)(3) purposes. DUO 58 Inc., organized to create self-sustaining businesses that donate 100% of their profits on a continual basis to fund humanitarian aid work in the U.S. and abroad as well as educate communities about social justice, is organized exclusively for charitable religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Upon dissolution of this organization and after payment of all outstanding debts of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, as allocated by the board of directors prior to dissolution.

**ARTICLE IV MANNER OF ELECTION** The manner in which the directors are elected and appointed:

All directors shall be elected by at least a two-thirds majority of the board. The president maintains the power to veto any candidate selection made by the board. Any board member may suggest a candidate for election by the board. The CEO shall be appointed by the board in the same manner that the board members are elected.




