I.

The name of this corporation shall be VOICES of HOPE for APHASIA Inc.; referred to in these Articles of Incorporation as VOICES.

II.

This corporation's place of business is 6830 Central Ave., St. Petersburg, FL 33707.

III.

This corporation is organized for the purpose of providing a therapeutic environment of innovative programs and a social connection for individuals afflicted with Aphasia. It is the intention of the Incorporators that VOICES qualify as a 501(3)(C) corporation under the United States' Internal Revenue Code.
