## ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

OF

### DOGS ON THE MOVE BY PAWSITIVE4LIFE, INC.

(Not for Profit Corporation)

Article III of the Articles of Incorporation of Dogs on the Move By Pawsitive4Life, Inc. is deleted in its entirety and replaced as follows:

#### Article III

The specific purpose for which this corporation is organized is to secure the safe haven of shelter animals from the South Florida area and help save as many animal lives as possible by transporting these at-risk animals out of South Florida to other parts of the country where they will be rehomed by reputable rescues and no-kill shelters. The corporation shall conduct such activities and functions which will further these purposes.

The corporation is organized exclusively for charitable, religious, educational and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.
