**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
SOUTH MANATEE BUSINESS COALITION, INC.**

Pursuant to *Section 617.1006, Florida Statutes*, the Corporation desires to amend its Articles of Incorporation having been filed with the Florida Secretary of State under Document Number N11000008868 (collectively the "Articles of Incorporation").

1. **Article I** is hereby deleted in its entirety and a new **Article I** shall replace any existing provision of the Articles of Incorporation. **Article I** shall read as follows:

ARTICLE I. NAME

The name of this corporation shall be SARASOTA MANATEE BUSINESS COALITION, INC.

2. All other terms and provisions of the Articles of Incorporation that were filed with the Secretary of State under Document Number N11000008868 shall remain unchanged.

3. There are no members of the Corporation. Pursuant to **Article VIII** of the Articles of Incorporation, the foregoing Amendment was adopted by the vote of all of the Directors of the Corporation on May 28, 2013.
