## Articles of Incorporation of

## Kingdom Ministry Leaders International Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: a ministry that exists to resurrect, revive, restore and reveal the glory of God in the body of Christ. Our burning desire and goal is to see whole churches, cities, regions and nations completely transformed by the power of God. We are an international ministry called to global harvest. Kingdom Ministries is an Apostolic and Prophetic Ministry sparking revival throughout North America and abroad by domonstrating power in the ministry of healing, signs and wonders and prophetic revelation. Our mission is to teach, train and equip the believing body of Christ how to live and move in the supernatural by emphasizing communion and intimacy with the Holy Spirit as completely essential for transformation.
