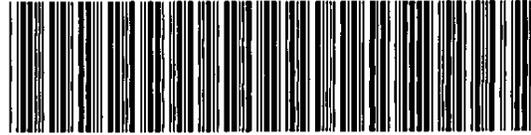

ARTICLES OF INCORPORATION

JUSTICE MCCLENDON MINISTRIES, INC.

*In Compliance With Chapter 617, Florida Statutes.*

The undersigned Chief Executive Officer of Justice McClendon Ministries Inc., citizens of the United States of America, for the purpose of establishing this "Not-for-profit" Corporation of the body of Christ, in the name of Christ, hereby certify the following Articles.

I

**Section 1.01 Name.** The name of this Corporation is Justice McClendon Ministries Inc (hereinafter referred to as this Church).

II

**Section 2.01 Principal Office.** The address of the initial principal office of this Church shall be

**Section 3.01 Purpose.** This Church is organized and operated exclusively for religious, charitable, and educational purposes (the perfecting of the saints, the work of the ministry, the edifying of the body of Christ), including, but not limited to, (1) to conduct bible conferences, revivals, evangelical campaigns, and other public worship services, (2) to teach and preach the Word of God, (3) to administer sacerdotal functions, such as holy communions, baptisms, ordinations, and other general religious services, (4) to establish, organize, and maintain churches, missions, and other public charities, (5) to train and license missionaries, ministers, deacons, and other qualified persons, (6) to spread abroad the gospel of justification by grace through faith in the redemptive work of Christ and of its resulting glory by radio, television, and literature, (7) to evangelize all nations, etc., within the meaning of the New Testament, Matthew 25: 34-46 and Matthew 28:19-20, and of the Internal Revenue Code sections 501(c)(3) and 170(b)(1)(A)(i).

**Section 5.03 Declaration of Independence.** This Church declares its independence as a member of the body of Christ, with the Lord Jesus Christ being its only Head and Founder under God. It is Apostolic by persuasion, Protestant in classification, Pentecostal in orientation, and Episcopal in polity. It shall not be inferior to any other ecclesiastical group, body, organization, association, convention, or fellowship. It shall be free to govern itself without outside interference from or control by other church groups, federal, state, or local government or agencies of such governmental bodies, or any other human authority. Furthermore, it believes the New Testament is the constitution of Christianity, the charter of the Christian church, the only authoritative code of ecclesiastical law, and the warrant and justification of all Christian institutions. Notwithstanding, this Church shall reverently fear and obey the laws of the U.S. Government (as long as such laws do not conflict with explicit New Testament doctrine) in accordance with the tenets of the New Testament, Romans 13:1-5, 1 Peter 2: 13-17, and Titus 3: 1.

**Section 6.01 Registered Agent and Address.** The undersigned is familiar with, and consent to, the appointment of registered agent. The address of the registered office is 451 W. **Section 5.01 Dissolution Clause.** In the event of dissolution, assets shall be distributed exclusively for a religious purpose within the meaning of sections 501(c)(3) and 170(b)(1)(A)(i) of the Internal Revenue Code or the corresponding sections of any future federal tax code.

**Section 5.02 Prohibitions.**

A. No part of the net earnings of this Church shall inure to the benefit of or be distributed to its members, directors, trustees, officers, or other private persons, except that the Church shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of this Church as set forth in Article III hereof.

B. No substantial part of the activities of this Church shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this Church shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding, any other provision of these Articles, this Church shall not carry on any other activities not permitted to be carried on (i) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (ii) by an organization to which contributions are deductible under section 170 (c) (2) of the Internal Revenue Code.
