Articles of Incorporation of

Kenton's Kowboy Klassic Inc.

Said organization is organized exclusively for charitable, religious, educational, and escientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: To educate the general public through yearly artifestivals and workshops and expose the general public to the many mediums of art including oil paints, acrylics, pastels, water colors, and sculpturing.

No part of the net carnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.
