St. Paul School of Excellence, Inc. is an approved elementary charter school in St. Johns County.
This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes,
the making of distributions to organizations that qualify as exempt organizations under 501(c)(3) of the Internal Revenue Code,
or the corresponding section of any future federal tax code.
Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on
(a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding
provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under section 170(c)(2)
of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).
Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of
section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code, or shall be distributed
to the Federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be
disposed by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located,
exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized
and operated exclusively for such purposes.
