Articles of Incorporation Of AAOL, Americans Against Oppressive Laws, Inc.

Article 1.

The name of the corporation is AAOL, Americans Against Oppressive Laws, Inc.

Article 2.

The initial registered office of the Corporation shall be at 6704 Kenwood Drive, North Port, FL 34287. The initial registered agent of the Corporation at such address shall be: Harold Muxlow.
