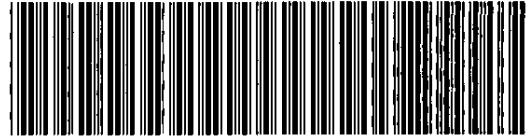

The undersigned incorporator to these articles of incorporation, hereby forms a not-for-profit corporation pursuant to the laws of the State of Florida.

ARTICLE I

NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE II

PURPOSE OF BUSINESS

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, healthcare related or educational within the meaning of s. 501(c)(3) of the United States Internal Revenue Code, or its future progeny and successor legislation (the "Code"). This organization shall not carry on any activities that are not permitted by an organization exempt from the payment of Federal income tax under the Code.

ARTICLE III

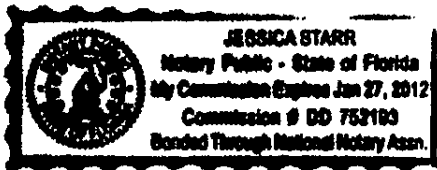

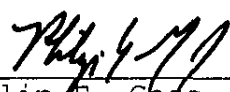
