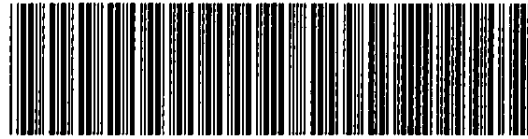

**ARTICLES OF INCORPORATION**  
**Of**

**A NON-PROFIT CORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation shall be the: Miami Youth Community Foundation, Inc.

**ARTICLE II. DURATION**

The period of the duration of this corporation is perpetual.

**ARTICLE III. PRINCIPAL OFFICE**

**ARTICLE IV. PURPOSE(S)**

The purpose for which the corporation is organized is exclusively for charitable, religious, educational, and scientific purposes under section 501(C) 3 of the Internal Revenue Code, or corresponding section of any future federal tax code.

**ARTICLE V. MANNER OF ELECTIONS OF TRUSTEES**

ARTICLE IX. CHARITABLE ORGANIZATION PROVISION

Notwithstanding any powers granted to the corporation by its Articles, By laws or by the laws of the State of Florida, the following limitations of power shall apply:


- a. The corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986, as amended ("Code").
- b. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in purpose clause hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from Federal income tax under section 501(c)(3) or (ii) by a corporation, contributions to which are deductible under section 170(c)(2).
- c. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Code Section 501(c)(3) or shall be distributed to the federal government, or a state or local government, for public purposes. Any such assets not so disposed of shall be disposed by the court having jurisdiction over the corporation exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized or and operated exclusively for such purposes.
