### ARTICLES OF CORPORATION

# EKKLESIA DORAL, INC. (NON- FOR PROFIT)

We the undersigned, in order to form a corporation under and pursuant to the provisions of Chapter 617 of the law of Florida for the purposes set forth below hereby subscribed to these Articles of Incorporation.

The Name of the Corporation shall be:

### **EKKLESIA DORAL, INC.**

The purpose and general nature of the entity/ business to be conducted and transacted by the corporation shall be as follow:

- A. To do and transact any all business as permitted under the laws of the State of Florida and the United States of America.
