## Article III

(a) This corporation in organized and shall be operated exclusively for the promotion of religious, charitable and educational purposes within the meaning of section 501 (C)(3) of the internal revenue code of 1986.

## (b) Notwithstanding any other provision of these Articles of Incorporation:

- (i) No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to any director or officer of the Corporations, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation and payments and distributions may be made in futherance of one or more of the purposes of the Corporation); and no director, officer, or any private individual shall be entitled to share in the distributions of any of the corporate assets on dissolution of the Corporation.
- (ii) No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.
- (iv) Upon the dissolution of th Corporation, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(C)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose, as determined by the Board of Directors of the Corporation. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
