ARTICLE 1

The name of the corporation shall be:

ARTICLE 3

This organization brought together solely for charitable and educational purposes and more specifically for the purpose of perpetuating ,preserving and advancing of Irish, Irish American and Celtic cultural heritage,to include, but not be limited to music art ,library,theater,dance and history, through charitable and educational means an activities,and including the grant of scholarships to groups and individuals which have a demonstrated record of advancing the same purposes. The Irish American Center ,Inc seeks to qualify as a not for profit group under section 501(c)(3) of the Internal Revenue Code. The corporation shall be empowered to engage in any lawful business.

ARTICLE 4

Directors shall be elected by majority vote of the membership.

ARTICLE 8

Members shall be persons of displayed interest in the preservation of Irish, Irish American and Celtic culture. Admission to membership shall be made by application. Acceptance shall require an affirmative vote by 2/3 of the board of directors.

ARTICLE 9

The Board of Directors of the corporation shall consist of not less than 3 persons and not more than 5 persons. This organization shall serve the interests of persons and Irish groups within The State of Florida only. The President, Secretary and Treasurer shall be members of the board of trustees by virtue of the office held. Said officers shall be elected for 2 year terms through a vote of the total membership.

ARTICLE 10

The Irish American Center, Inc shall be empowered to engage in all lawful business activities which are consistent with the charitable and educational purposes of the organization.

ARTICLE 11


This corporation shall not be for profit. No part of the earnings of the organization shall inure to the benefit of, or be distributable to its members officers or other private persons, other than qualified scholarships. The corporation may pay reasonable compensation for services rendered and make payment and distributions to Irish groups and/or activities which demonstrably serve the purposes of preserving Irish heritage as stated in our goals.

ARTICLE 12

This corporation is on a non stock basis. Money paid out by persons for the re-instating of the corporation may be reimbursed as monies become available.

ARTICLE 13


