ARTICLE I NAME UNITED BELIEVERS IN CHRIST, INC.

ARTICLE II RESTATEDA RTICLES PURPOSE:
The text of the Restated Articles is as follows:

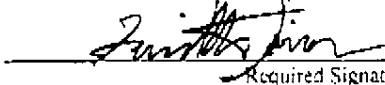

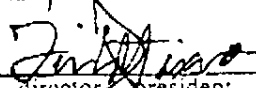
