The undersigned acting as incorporators of a corporation pursuant to Florida Corporation Law Statute 617, adopts the following Articles of Incorporation.

**ARTICLE I
NAME**

The name of the corporation shall be:

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

**ARTICLE III
PURPOSES**

1. To formulate develop and implement a healthy living program designed to combat social and economic ills that negatively effect the health and well being of disadvantaged communities.
2. To operate a healthy living restaurant designed to educate the public at large on healthy dietary choices.
3. To provide counseling and life skills to parents and children from economically and socially disadvantaged neighborhoods.
4. To educate the children and families from economically and socially

disadvantaged communities about obesity and diabetes prevention life styles.

5. The organization is organized exclusively for charitable, religious, educational or scientific purposes under section 501 (c) (3) of the Internal revenue Code or any future federal tax

ARTICLE IV DISSOLUTION

Upon dissolution of the corporation either as an act of law or by resolution of the Board of Director assets of the corporation shall be distributed to a non-profit 501 (c) (3) corporation. "However" if the named recipient is not in existence as a distributee, or is unwilling to accept the distribution, the assets will be distributed to a fund, or foundation, or organization which operates exclusively for purposes specified in section 501 (c) (3) of the Internal Revenue Code of 1986 of any corresponding provision of any future Internal Revenue Law.
