Articles of Incorporation of the undersigned, who is over 18 years of age and a citizen of the United States desires to form a Non-Profit Corporation, pursuant of the provisions of the State of Florida.

Article I

The name of the corporation shall be Sew Pretty Corp

Article II

The principal office of the Corporation is to be located at 11633 Timberline Circle, Fort Myers Florida 33966.

Article III

The business and purpose of the corporation shall be to provide community programs offering emotional, behavioral, and physical cellular healing through work and production of handicap accessories and purses, to donate profits to charity. Sew Pretty makes custom handicap accessories and hand-made purses. The company is initially starting out as a small home based sewing and embroidery business donating profits to MS research and Disabled Veterans. Sew Pretty will design and make purses and disabled accessories for disabled equipment. The profits will be donated to Multiple Sclerosis Research and to "Paws for Patriots" charity which provides seeing-eye guide dogs for blinded veterans. As the company grows and is in a position to hire part time help to meet demand, people with Multiple Sclerosis or Disabled Veterans will be given first consideration. These will be part time positions with wages that will fall within the disability laws. If training to produce the purses and/or perform other business and computer duties is needed to continued growth of the company, computer and sewing training will be provided for the members/employees or trustees from within the corporation.

a. Said corporation is organized exclusively for the benefit for charitable, religious, educational, and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organization under Section 501 (c) (3) organizations. Sew Pretty designs and manufactures custom purses, and disabled accessories, used on disability equipment. Profits will be donated to Multiple Sclerosis, Research and Services, also to Disabled Veterans. Education for such purposes, (computer and sewing) as making and distributing charitable contribution to qualify as an exempt organizations under Section 501 (c) (3) of the Internal Revenue Code or corresponding sections of any future federal tax code.
