ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

PALM BEACH COMMUNITY CHURCH FOUNDATION, INC., under

its corporate seal in the hands of its duly elected President and Secretary, Raymond Underwood and Paul Connealy, respectively, hereby certify that:

the members of the said corporation, at a meeting called for said purpose on the 7th day of November, 2012 and after notice as required, adopted the following resolutions:

BE IT RESOLVED by the members of PALM BEACH COMMUNITY CHURCH FOUNDATION, INC., that said members deem and hereby declare it to be advisable that the Charter of Articles of Incorporation of said corporation be amended, changed and altered to read in its entirety, through all Articles thereof, as follows:

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME OF THE CORPORATION

The name of this corporation shall be Palm Beach Community Church Foundation, Inc.

ARTICLE II PRINCIPAL OFFICE

The address of this corporation is 4301 PGA Blvd., Palm Beach Gardens, FL 33418.

ARTICLE III EXISTENCE

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV PURPOSE

The purposes for which Palm Beach Community Church Foundation, Inc is organized are exclusively religious, charitable, literary and educational including, but not limited to, for such purposes, the formation of a Christian Church to promulgate the Gospel of Jesus Christ under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

The powers of Palm Beach Community Church Foundation, Inc. are limited to those within the scope of section 501(c)(3) of the internal revenue code of 1986 of the corresponding provision of any future United States Internal Revenue law.

SECRETARY OF STATE DIVISION OF CORPORALISMS

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code or corresponding section of any future Federal tax code.

ARTICLE V DIRECTORS

The business of the corporation shall be conducted by a Board of Directors which shall consist of not less than three (3) unrelated persons as shall be designated by the by-laws, and elected at the annual meeting, or at a specially-called meeting for the purpose of electing a director of this corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

Upon dissolution of the organization all assets shall be distributed to one or more Christian 501(c)(3), religious organizations within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, State or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court in the county in which the principal office of the organization is then located, exclusively for such purposes.
