the board of Directors of the said corporation, at a meeting called for said purpose on the 21st day of October, 2014 and after notice as required, adopted the following resolutions:

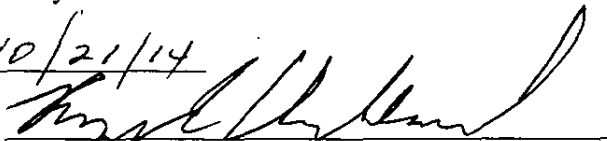
