Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

A. ARTICLE III - PURPOSE is replaced with the following:

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, making distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Included in the Corporation's purpose is providing counseling, and spiritual, economic, educational and financial empowerment to individuals in ways that would impact communities locally and internationally.

B. ARTICLE VI - DURATION AND DISSOLUTION (This new article is added):

The Corporation shall exist perpetually until dissolution. Upon dissolution, the Corporation's assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding sections of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose.
