ARTICLES OF INCORPORATION

OF

Kiwanis of Dade City Charitable Foundation, Inc. Pursuant to Chapter 617 of the Florida Statutes (Not for Profit).

ARTICLE I - NAME

The name of this corporation is KIWANIS OF DADE CITY CHARITABLE FOUNDATION, INC.

ARTICLE II - PRINCIPLE OFFICE

The principal place of business of this corporation is 14144 Sixth Street, Dade City, Florida 33525. The mailing address of this corporation is Post Office Box 353, Dade City, Florida 33526.

ARTICLE III - PURPOSE

The primary purpose of the corporation shall be to provide charitable services to the needy in Dade City, Florida, and the surrounding area, with efforts primarily geared towards needy children. The corporation is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
