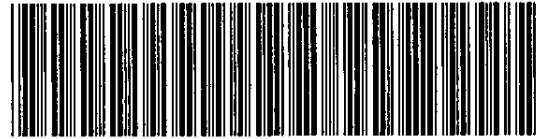

Article IX.

A.
