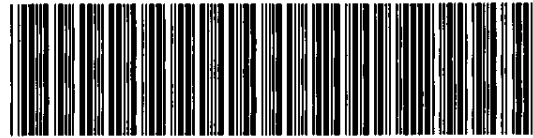

Article III Purpose

This corporation is organized for social welfare and educational purposes, more specifically to create a new generation of young men who will pledge to love and respect women and young girls, serving as protectors; refusing to objectify and subject them to the abuse, mistreatment, and immoral behaviors that have become commonplace in our society. To this end, the corporation shall at all times be operated exclusively for educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.
