## ARTICLES OF INCORPORATION

We, the undersigned, for the purpose of forming a not for profit under the Laws of the State of Florida, Florida Statutes 617, hereby adopt the following Articles of Incorporation.

Article 1: The name of the Corporation hereafter referred to as

*Protector*  
*Against the Nemesis, Inc.*

Article 2: The place in this state where the principal office of the Corporation is 3221 Deerfield Drive 33619 Tampa, Florida, Hillsborough, County.

Article 3: 1. Said corporation is organized exclusively for charitable and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation is organized to provide food, shelter and counseling and other resources to the homeless in Hillsborough County, Florida. *Protector Against the Nemesis, Inc.*

~~Protector Against the Nemesis, Inc.~~, Inc. shall be nondiscriminatory in policy and shall not discriminate on the basis of race, color, nationality, religious denomination, sexual orientation, ethnic origin, gender or age in administration of any of its services.

Article 4: The duration of the corporation shall be perpetual unless it shall hereafter be dissolved according to the law.

Article 5: The manner in which the directors are elected or appointed is provided in the bylaws.

Article 7: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this

corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of the corporation.

Article 8: Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.
