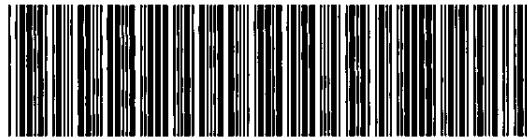

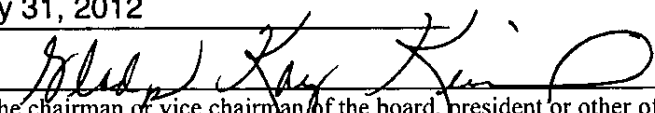

- a.
