Exhibit 1 (Statement of Purpose)

Articles of Incorporation: Veterans Housing Solutions and Support Services, Inc.

Article III: Purpose

To provide diverse housing solutions, comprehensive support services including community resource referrals for displaced United States veterans. Said organization is organized exclusively for charitable, religious, educational and scientific purposes including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code or shall be distributed to the federal govt or to a state and local government for a public purpose. Any such assets not disposed of, shall be disposed of by the Court of Common Pleas of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
