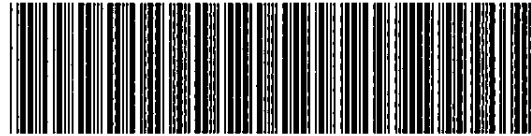

ARTICLES OF INCORPORATION
OF
ZOW INTERNATIONAL CHURCH OF OUR LORD AND SAVIOR JESUS CHRIST, IN
A NON PROFIT ORGANIZATION

UThe undersigned being desirous of forming a corporation under the provisions of Chapter 607 of the Florida Statutes do agree to the followings:

ARTICLE I

The name of the corporation is: Zow International Church Of Our Lord and Savior Jesus Christ, Inc., and its principal office is located at 1437 NE 1st Avenue, Fort Lauderdale, Fl 33304.

ARTICLE II

This corporation shall have perpetual existence unless dissolved pursuant to the law. Its existence shall commence upon filing With the Secretary of State.

ARTICLE III

The purpose for which the corporation is organized are exclusively charitable, scientific, literary, and educational with the meaning of section 501(c)3 of the Internal Revenue Code, or the corresponding provision of the future United States Internal Revenue Law. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

This corporation shall have the right to promote spiritual and intellectual welfare of the people of the State of Florida; the buying, selling, conveying, accepting and being invested with all manner of estate, real, personal and mixed. To operate a day care center and to all manner of gospel programs.

ARTICLE IV

The qualification for members and the manner of their admission is to be provided for in the Bylaws.

ARTICLE V
