ARTICLES OF INCORPORATION
For

A Non Profit Corporation

ARTICLE I - NAME

The name of the corporation shall be **Young Families Health Initiatives, Inc.**

ARTICLE II - ADDRESS

The principal street address of this corporation shall be:

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is to have a positive effect on the lives of Lake County families through prenatal and postnatal education. The annual Lake County Baby Fairs are free community education events sponsored by Young Families Health Initiatives, Inc. These fairs are designed for first-time or special needs parents, and they provide information on positive parenting, child safety, and healthy lifestyles. Young Families Health Initiatives, Inc. is organized exclusively for charitable, educational, religious, or scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section.

ARTICLE IV – ELECTION OF BOARD MEMBERS

The Board of Directors shall be the governing body of the Corporation and shall consist of three or more individuals, with the total number specified in accordance with the by-laws. The number of Directors may change over time; however, the Corporation shall have no fewer than three directors. The manner in which the directors are elected and appointed is by a majority vote (more than ½) of the remaining members present.

No part of the net earnings of Young Families Health Initiatives shall inure to the benefit of, or be distributable to, any of its members, officers, or other private persons, except that the corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes.

No part of the organization's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding, any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal code.

ARTICLE VIII - DISSOLUTION

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations, as stated in the by-laws, which themselves are exempt as an organization described in section 501(c)(3) of the Internal Revenue Code, as amended, or corresponding sections of any prior or future law.

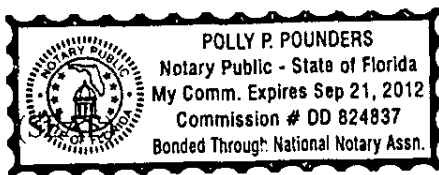


