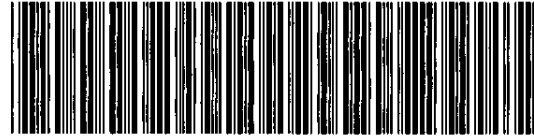

## **THE GOSPEL MINISTRIES, INC.**

### **Article Purpose:**

- (a) To establish a spiritual association of togetherness that will exhort and inspire the consciousness of it's members and the public.
- (b) To conduct religious worship and instruction, churches schools, pastorioms and other institutions connected therewith of a religious, educational, charitable and love of mankind character to the end that it's own members and others may be generally instructed and given direction.
- (c) To study, teach and exemplify the doctrines of the Gospel Ministries, Inc., especially the teachings of Jesus; and to present Christianity in it's modern setting
- (d) To study and practice spiritual healing as set forth in the bible.
- (e) To establish and oversee places of worship, conduct the work of evangelism worldwide, create departments necessary to support missionary activities and to license, ordain, certify duly qualified ministers. Teachers, counselors evangelists, deacons and missionaries of the gospel.
- (f) To establish and distribute lessons, discourses, and other educational materials in pursuance of the above objectives.
- (g) To make a worthy contribution of the spiritual, religious, cultural, and educational life of all geographical locations in which the church or it's members are active.
- (h) To aid and assist underprivileged children and adults and teach evangelism This corporation shall have all the powers set forth under the provisions of the Florida Statues as they now exist as they become amended from time to time, including the power to raise and expend funds for the carrying out the purpose of this corporation, including mail solidification and otherwise; the borrowing of money; grants, the right to own personal property and real property in this state or any other state or country; the power to sign and enter into contracts and other legal instruments; and the right to sell such terms as the corporation seem desirable.

1V Elections by all officers shall be annually in accordance with the by-laws, with the exeception of the president who will have life temure. By virtue of the president calling and being chief steward of this church, the founder Carole S. Dixon of this organization is automatically ordained as pastor. All other candidates for licensing or ordination must be of the necessary experience and qualification, as set forth by the founder and shall have demonstrated their ability to undertake the responsibilities of the Full gospel ministry. No minister shall be licensed or ordained until he/she shall have been engaged in active work of the ministry, exhibiting a teachable spirit. Credentials shall be valid only when sealed by the church seal. And shall be renewed annually.
