

## Articles of Incorporation of

Said organization is organized exclusively for charitable, religious, educational, and ic purposes, including, for such purposes. The making of a such purposes. scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: to partner with local restaurants to recycle waste vegetable oil into clean burning biodiesel fuel, which is used to fuel local community vehicles. Proceeds from this fund raising activity are used to fund scholarships for students interested in studying. renewable energy, energy efficiency, and sustainable living topics.

No part of the net carnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers; or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of this organization shall be the carrying on propaganda, or otherwise attempting to influence legislation, and this organization shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office.
