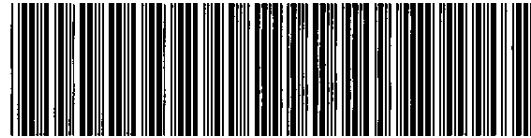

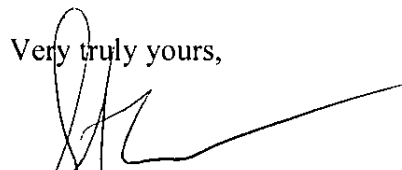

**ARTICLES OF INCORPORATION
OF

A NON-PROFIT CORPORATION**

The undersigned, for the purpose of forming a corporation under Chapter 617 of the Florida Statutes, the Florida Not-For-Profit Corporation Act, hereby certifies:

ARTICLE I - NAME

The name of this corporation shall be **FROM OUR HANDS TO YOURS, INC.**

ARTICLE II - ADDRESS

ARTICLE III - PURPOSE

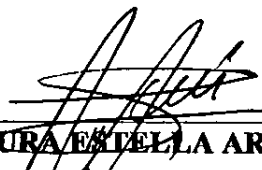
Any amendments to these Articles of Incorporation shall be made in accordance with the provisions of the laws of the State of Florida.
