Articles of Incorporation

(In Compliance with Chapters 617, F.S., (Not for Profit)

Article I Name

The name of the corporation shall be: Ditchfield Music for Life, Inc.

Article II Principal Office

The principal place of business and mailing address of this corporation shall be:

2825 Pinecrest St. Sarasota, Fl. 34239

Article III Purpose

The purpose for which the corporation is organized is to promulgate the Gospel of Jesus Christ through radio, television, music, and internet broadcasts; additionally through publications, seminars, musical productions, meetings, and conferences; to evangelize the lost; to minister help and encouragement to the needy; to train and disciple adherents, to engage in any lawful activity for which non-profit corporations may be organized under the general corporate Law of Florida.
