WE, The Undersigned, desirous of forming a Not-for-Profit Corporation,
under the laws of the State of Florida, having associated ourselves together for such
purpose, submit the following Articles of Corporation:

ARTICLE I - NAME

The name of this corporation shall be:

JEHOVA-YIRE TRIBAL MINISTRIES, ASSEMBLIES OF GOD, INC.

ARTICLE II - TERM

This corporation shall have perpetual existence unless dissolved sooner by
operation of Law.

ARTICLE III - PRINCIPAL OFFICE

The principal place of business of the Corporation shall be:

Miami, FL 33125

ARTICLE IV - PURPOSES

Section 1. This corporation is being formed exclusively to bring the Gospel of our Lord
Jesus Christ to the tribes in the jungle, and help them with their basic needs of housing,
food, education and health.

Section 2. No part of the net earnings of the Corporation shall inure to the benefit of,
or be distributable to its members, trustee, officers, or other private persons, except that
the Corporation shall be authorized and empowered to pay reasonable compensation for
services rendered and to make payments and distributions in furtherance of the purposes
set forth in this Article. No substantial part of the activities of the Corporation shall be

the carrying on of propaganda, or otherwise attempting to influence legislation in or
intervene in any political campaign on behalf of any candidate for public office.

Section 3. Notwithstanding any other provision of these Articles, this Corporation, shall
not engage in any activities or exercise any powers that are not in furtherance of the
purposes of this Corporation.

Section 4. Upon dissolution of the Corporation, the Board of Directors shall, after
paying or making provisions for the payment of all the liabilities of the Corporation. No
person, firm, or corporation shall ever receive any dividends or profit from the under-
takings; and upon dissolution of this corporation, assets shall be distributed for one or
more exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue
Code of 1986, or corresponding section of any future federal tax code, or shall be distri-
buted to the Federal, State or Local government for public purposes.

ARTICLE V – POWERS

This Corporation shall exercise these powers conferred by Florida Statutes for
Corporations Not for Profit and such shall be limited to only those powers that are in
furtherance of the charitable and exempt purpose of the Corporation.

ARTICLE VI – MEMBERSHIP

Membership in this Corporation shall consist of the initial subscribers to these
Articles and other persons who from time to time may be elected to membership by the
Board of Directors at any regular meeting or special meeting called for such purposes in
accordance with their support and interest in the Corporation's activities.

ARTICLE VII – BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors, consisting of not more than five (5) and never less than one (1) Directors. Those persons who will serve as Directors until the annual meeting of the membership and/or until their successors are elected.

ARTICLE VIII – OFFICERS

The Officers of the Corporation shall be President, Vice President, and other officers as may be elected or appointed by the Board of Directors from time to time. The names, addresses and titles of those persons who will serve as officers until their successors are elected are as follows:

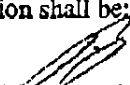

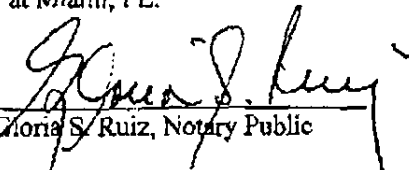

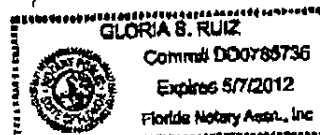
