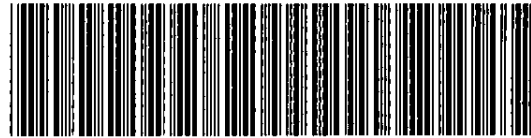

The purpose for which the corporation is organized is:

1.
