ARTICLES OF INCORPORATION OF KINGDOM GLOBAL MINISTRIES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1. NAME:

The name of the Corporation shall be Kingdom Global Ministries, Inc.

ARTICLE II. PRINCIPLE OFFICE:

ARTICLE III. PURPOSES:

- A. This Corporation is a not-for-profit Religious, Charitable, Corporation organized under Chapter 617 Florida Statutes. It is not organized for the private gain of any person. The specific purpose for which the Corporation is organized is for Kingdom Advancement by developing an Apostolic Life Center (multi-culture church) where the Kingdom of God is Preached and Demonstrated through God's Covenantal Promises of; Salvation, Healing and Deliverance both locally, and Globally. 
