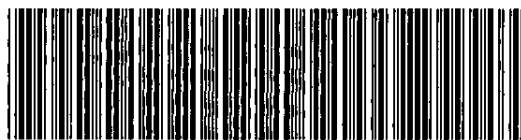

**ARTICLES OF INCORPORATION
OF
National Parkinson Foundation South Florida, Inc.**

These Articles of Incorporation are hereby made and acknowledged by the undersigned incorporator, to be filed with the Secretary of State, State of Florida, for the purposes of forming a not for profit corporation in accordance with the laws of the State of Florida.

ARTICLE I – NAME AND ADDRESS

- a) The name of the corporation shall be **National Parkinson Foundation South Florida, Inc.**
- b) The principal office of the corporation shall be **1501 NW 9th Avenue, 1st Floor, Miami, FL 33136**
- c) The Mailing address of the corporation shall be **PO Box 3616, Hallandale, FL 33009**

ARTICLE II – REGISTERED AGENT

The name of the initial registered agent of the corporation is **Audrey Wood**. The address of this registered agent is **1501 NW 9th Avenue-Bob Hope Road, 1st floor, Miami, FL 33136**

ARTICLE III – CORPORATE EXISTENCE

The existence of this corporation shall commence as soon as permissible by law. The duration of the corporation shall be perpetual.

ARTICLE IV – BOARD OF DIRECTORS

The method of selection of the Board of Directors and number of directors shall be stated in the bylaws.

ARTICLE V – CORPORATE PURPOSES

The purposes for which this corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue law. Notwithstanding any other any future United States Internal Revenue law. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE VI – LIMITATIONS

Notwithstanding any powers granted to the Corporation by its Articles, Bylaws or by the laws of the State of Florida, the following limitations of power shall apply:

- A. No part of the net earnings, gains or assets of the corporation shall inure to the benefit of or be distributable to its members, nonvoting members, directors or officers, other private individuals, or organizations organized for a profit; provided however the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IX, hereof, to the extent permitted by law.

- B. Notwithstanding any other provisions in these Articles, the corporation shall not carry on any activities not permitted to be carried on by (a) an organization exempt from federal income tax under Internal Revenue Code Section 501(1) as an organization described in Internal Revenue Code Section 501(c)(3) and (b) an organization described in Internal Revenue Code Sections 509(1)(1), (2), or (3), (as the case may be); and/or (c) by an organization, contributions to which are deductible under Internal Revenue Code Sections 170(c)(2), 2055(a)(2), or 2522(a)(2).
- C. No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.

ARTICLE VII – DISSOLUTION

In the event of dissolution or final liquidation of this corporation, the Board of Directors shall, after paying or making provision for the payment of all the lawful debts and liabilities of the corporation, distribute all the assets of the corporation to one or more organizations which themselves are exempt under Internal Revenue Code Section 501(c)(3).

ARTICLE VIII – INDEMNIFICATION

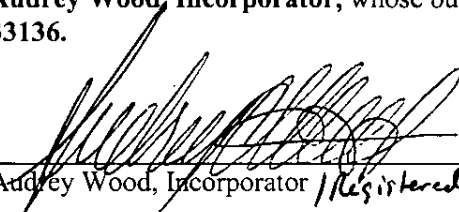
This corporation shall indemnify all officers and directors, and former officers and directors, to the fullest extent permitted by law as the law now exists or may be amended hereafter.

ARTICLE IX – NONDISCRIMINATION

No person shall be denied membership, association with, participation in the programs of, or other involvement with the business and services of the corporation on the basis of race, creed, national origin, age, sex, handicap, or religion. This principal shall be reflected in the Bylaws, and in the policies and programs subsequently enacted by the Board of Directors.

ARTICLE X – INCORPORATION
