

## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I**                      **NAME**

The name of the corporation shall be Saints Booster Club, Inc.

### **ARTICLE II**                      **PRINCIPAL OFFICE**

In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under IRC Section 501(c)(3), or corresponding provisions of any subsequent Federal tax laws, or to the Federal, state or local government for a public purpose.
